Advancer Global To Acquire Three New Pest Control and Fumigation Companies to augment its Integrated Facilities Management Services

SINGAPORE, 25 October 2016– Advancer Global Limited (“**Advancer Global**” or the “**Company**” and together with its subsidiaries, the “**Group**”), an established and diverse integrated services provider offering workforce solutions and services in Singapore, announced today that the Company, through its wholly-owned subsidiary, Advancer Global Facility Pte Ltd, has entered into a sale and purchase agreement to acquire 100% interest in three companies, Premier Eco-Care Pte. Ltd. (“**Premier**”), Prestige Enviro-Care Pte. Ltd. (“**Prestige**”), a wholly-owned subsidiary of Premier, and Green Management Pte. Ltd (“**Green Management**”), collectively known as the “**Acquired Companies**”, for an aggregate initial cash consideration of S\$3 million to grow its facilities management businesses. A further consideration will be determined as at 31 December 2017.

Premier and Prestige offer mainly pest control and fumigation solutions as well as other complementary services such as disinfection services as well as garden and lawn care. Led by experienced industry veterans and well-trained technicians, these companies have built an established customer base and a proven track record in the pest control industry. Green Management, which is a licensed fumigator, is currently dormant and has not commenced any business operations.

“The acquisition will enable the Group to attain a larger skilled workforce to drive the pest control business and provide a wider range of service offerings with more advanced treatment methods to a larger pool of customers, thereby deepening its market penetration and expanding its market share in the pest control industry in Singapore. This is in line with the Group’s long-term strategy to become a comprehensive one-stop shop provider of integrated facilities management services. The Group will also be able to tap on the existing

customer pool of Premier and Prestige to cross-sell for its current services.” said Mr Gary Chin, Chief Executive Officer and Executive Director, Advancer Global Limited.

The initial cash consideration for the acquisition will be funded via the proceeds raised from the initial public offering of the Company.

Advancer Global Limited (“**Advancer Global**” and together with its subsidiaries, the “**Group**”) is an established and diverse integrated services provider offering workforce solutions and services in Singapore through three business segments, namely Employment Services Business, Cleaning and Stewarding Business and Security Services Business.

The Group offers one-stop shop services for the sourcing, employment and training of Foreign Domestic Workers (FDWs) to households, as well as the sourcing and employment of foreign workers to amongst others, corporations and organisations (the “**Employment Services Business**”) through its subsidiaries, Nation Employment Pte Ltd and Enreach Employment Pte. Ltd, Nation Human Resources Pte. Ltd and APAC Cities Employment Pte Ltd..

The Group also provides integrated cleaning and stewarding solutions and services to, amongst others, hospitals, hotels, commercial and residential properties, as well as pest control services (the “**Cleaning and Stewarding Business**”) through its subsidiaries, MasterClean Facility Services Pte. Ltd., World Clean Facility Services Pte. Ltd., First Stewards Private Limited and Unipest Pte. Ltd.

The Group’s third core business is the provision of manpower for security solutions and services to, amongst others, commercial, industrial and residential properties, as well as security escort services (the “**Security Services Business**”) through its subsidiaries, KC Security & Investigation Services Pte. Ltd, KH Security Agency Pte. Ltd and Ashtree International Pte Ltd.

The Cleaning and Stewarding Business and the Security Services Business, which are integrated and complementary, collectively constitute the “**Facilities Management Businesses**”.

On 9 September 2016, the Group acquired 76% of the total issued and paid-up share capital of Newman & Goh Property Consultants Pte Ltd (“**NGPC**”) and its associate company, Newman & Associate Pte Ltd (“**NAPL**”). NGPC is engaged in the provision of property consultancy, property and facilities management services for residential, commercial and industrial properties in Singapore. Other services include property valuation, investment sales, as well as property agency services. Its associate company NAPL provides complementary services to NGPC. The acquisition of NGPC and NAPL is synergic to the Group’s current Facilities Management Businesses and enable the Group to position itself as an efficient one-stop shop facilities management solutions and services provider.

The Group has more than 500 corporate customers in relation to the Facilities Management Business, ranging from hospitals, multinational corporations, shopping malls, hotels and resorts, management corporations of residential and commercial properties, food and beverage shops and entertainment venues.

About Premier Eco-Care Pte. Ltd.

Established in 2008, Premier is a well-recognized pest control and fumigation company known for its reliability and service quality in meeting the needs of the general community and businesses of Singapore. It mainly offers a full range of services including pest control, fumigation, soil treatment for termite control, bird control, disinfection services, garden and lawn care as well as ecological-care products.

About Green Management Pte Ltd

Green Management, incorporated in 2009, is currently a dormant company and has not commenced any business operations.

Premier, Prestige and Green Management are all accredited by the Agri-Food & Veterinary Authority of Singapore (“AVA”) as treatment providers to perform fumigation for solid wood packaging materials and other agricultural commodities under International Standards for Phytosanitary Measures (i.e. ISPM 15) of the International Plant Protection Convention (“IPPC”) Strategic Framework. As accredited treatment providers by the AVA, they are allowed to issue certificates to certify that the solid wood packaging materials or other agricultural commodities have been treated in accordance to the standard such as ISPM 15 and other treatment specifications imposed by the importing countries, such as requirements imposed by the Australian Quarantine & Inspection Service (“AQIS”) under the Australian Fumigation Accreditation Scheme (“AFAS”), for cargos bound for Australia.
