ADVANCER GLOBAL SET TO DRIVE GROWTH IN FACILITIES MANAGEMENT SERVICES THROUGH ACQUISITION OF LANDSCAPING COMPANY

Singapore, 26 November 2018 – Advancer Global Limited (前进集团有限公司) (the “Company”) together with its subsidiaries and associate companies (“**Advancer Global**” or the “**Group**”) announced today that its wholly-owned subsidiary, Advancer Global Facility Pte. Ltd. (“**AGF**”), together with Fat Trees Pte. Ltd., a company incorporated in the Republic of Singapore have acquired Country Cousins Pte. Ltd. (“**Country Cousins**”), a Singapore-registered company providing landscaping and related services.

Country Cousins, established in 2014, serves a wide range of customers comprising schools and tertiary institutions, offices and commercial spaces, private residential homes and public gardens. The company offers a full suite of professional services from landscape planting, care and maintenance services such as garden installation and maintenance, grass cutting, tree felling and pruning in Singapore.

Pursuant to the acquisition, AGF will hold 76% of the total issued and paid-up share capital of Country Cousins while the balance of 24% is being held by Fat Trees Pte. Ltd. Out of the total consideration of S\$225,000 for 100% of the total issued and paid-up share capital of Country Cousins, AGF will pay S\$171,000 which will be funded from the net subscription proceeds arising from the subscription of shares in the Company by Fullcast Holdings Co. Ltd. that was completed on 31 August 2018.

Mr Gary Chin, CEO & Executive Director of Advancer Global said, “Country Cousins’ current business complements strategically the Group’s services in outdoor living spaces, and facilitates our entry into aquascapes and pondsapes to enhance the eco-environment where we work, live and play. Our customers will ultimately benefit and gain access to a wider range of solutions for their landscaping needs, as well as, access to an experienced and highly skilled landscaping team. We are convinced that the Group and the Facilities Management Division will develop positively with the acquisition and further expand our footprint in the landscaping business.”
